WRITING ASSIGNMENTS

Each student will answer questions after each session that is related to the topic and each student will do follow-up activities with their teen which will be handed into the instructor on the following week.

OUTSIDE ASSIGNMENTS

Create a family mission statement and practice family meetings, communication, and positive discipline techniques.

APPROPRIATE ASSIGNMENTS THAT DEMONSTRATE CRITICAL THINKING

Group and follow-up activities. Develop strategies for setting boundaries and setting clear expectations. The student will use tools to communicate more effectively and find positive qualities in their teen.

EVALUATION

- 1. Attendance and class participation.
- 2. Upon completion of Juvenile Court Parenting course the student will be required to give an oral presentation describing what they learned from this course and the tools they are using in parenting. In addition, each student will be required to hand in a 500 personal word essay.

METHOD OF INSTRUCTION

The method of instruction will include, but are not limited to: lecture, class discussions, group and follow-up activities, handouts, videos, guest speakers, and field trips.
