### COURSE GOALS

Upon completion of the two semester course, students will be proficient in the content standards identified by the California Department of Education for Grade 10: World History, Culture and Geography: The Modern World. Among these are: causes and consequences of World War II; international developments in the post World War II world; nation building in the Middle East, Africa, Mexico and other parts of Latin America, and China; integration of countries into the world economy, and the information technological and communications revolutions.

### COURSE OBJECTIVES

Upon successful completion of this course students will be able to:

- 1. Analyze the causes and consequences of World War II (Including focusing on similarities and differences among Germany, Italy, and Japan; role of appeasement and isolationism; Nazi policy of racial purity; human costs of war).
- 2. Analyze the international developments in the post-World War II world (Including power shifts in post war era; causes and effects, key events of Cold War; effects of Cold War in developing countries; Chinese Civil War; End of Cold War).
- 3. Analyze instances of nation-building in the contemporary world in at least two of the following regions or countries: the Middle East, Africa, Mexico and other parts of Latin America, and China (Include an understanding of the challenges in the regions, such as geopolitical, cultural, military, and economic).
- 4. Analyze the integration of countries into the world economy and the information, technological, and communication revolutions (e.g., television, satellites, computers).

- 13. Effects of the Information, Technological and Communication Revolutions

### APPROPRIATE ASSIGNMENTS THAT DEMONSTRATE CRITICAL THINKING

Critical thinking assignments may include, but are not limited to the following:

- 1. Explain how a source provides information about the broader historical setting within which it was created.
- 2. Explain the relative historical significance of a source's point of view, purpose, historical situation, and/or audience.
- 3. Support an argument using specific and relevant evidence.
- 4. Use historical reasoning to explain relationships among pieces of historical evidence.
- 5. Consider ways that diverse or alternative evidence could be used to qualify or modify an argument.

### **EVALUATION**

A student's grade will be based on multiple measures of performance that may include, but are not limited to the following:

- 1. Exams.
- 2. Responses to worksheets.
- 3. Writing assignments.
- 4. Class participation.
- 5. Attendance per current policy.
- 6. Oral presentations.

Upon successful completion of each individual course a Certificate of Course Completion will be issued. Upon successful completion of all courses included in the program a Certificate of Program Completion will be issued.

#### METHOD OF INSTRUCTION

Methods of instruction may include, but are not limited to the following:
