# WIOA 101

- **Workforce Innovation & Opportunity Act Title II, Adult Education & Family Literacy Act**
  - The WIOA, Title II: Adult Education and Family Literacy Act (AEFLA) grant provides *supplemental funds* over a 4 year grant cycle for adult education to (1) assist adults to become literate and obtain the knowledge and skills necessary for employment and economic self-sufficiency; (2) assist adults who are parents or family members to obtain education and skills; (3) assist adults in attaining a secondary school diploma and postsecondary education and training, including through career pathways; and (4) assist immigrants and other individuals who are English language learners. (administered by the Department of Education through each state)

## PART D—GENERAL PROVISIONS

### § 3331. Administrative provisions

#### (a) Supplement not supplant

Funds made available for adult education and literacy activities under this subchapter shall supplement and not supplant other State or local public funds expended for adult education and literacy activities.
