FIVE VISITING COMMITTEE KEY RECOMMENDATIONS

4. Maintain and secure technology in support of data-driven instruction, decision making, and student services.
5. Use Integrated planning to support institutional and student success.

Progress Highlights on Recommendation #2:

In 2018/19, through the allocation of Strong Workforce funding, SDCE renovated two career centers and implemented a Career and College Transitions Program to increase workforce opportunities for students. A Dean of College and Career Transitions, three job developers, and one Job Placement Coordinator were hired to support this work. (Evidence: Special Projects Manager report)

YEAR 3 PROGRESS REPORT

The 2019/20 academic year represented a transition from building infrastructure, systems, and processes to reporting and progress oversight of the institution's progress on key Institutional Strategic goals for 2016-2021 and their related Accreditation Action Plan growth areas. Progress on both the Institutional Strategic Plan and the Accreditation Plan action steps were reviewed this spring by the Accreditation Sub-Committee, the Planning and Institutional Effectiveness Committee, President's Executive Cabinet, and President's Cabinet, culminating in an update presented to EGC in May. Mid-cycle report writing is underway, with the expectation that the mid-cycle report will be ready to review with constituencies in the fall in preparation for the spring 2021 one-day visit.

SDCE RESPONSE TO COVID-19 PANDEMIC


The recent events related to the Covid-19 Pandemic have impacted all areas of SDCE, beginning in late March, with campus closures, in-person class transitions to remote/on-line delivery, and transitions by nearly all employees to remote work conditions. SDCE has

responded to support SDCE students, faculty and staff.

President Carlos Turner Cortez launched the first of what will be regularly scheduled 'SDCE in Focus' Community Town Meetings on April 1, 2020. Designed to 'share information as quickly

as possible when decisions are made that impact SDCE students, processes and operations' as well as to 'hear and share examples of the positive work we are doing to support our students and one another.' The first Meeting was attended by 180+ participants, with meetings also held on April 8th & 22nd, with more to come.

Support to Students: Within a few short weeks, registration processes were moved to remote/online-only, with Classified Professional, Counseling, Faculty, IT & Administrative staff working creatively and collectively to reach out to students. With support from the Rising to Success program, San Diego Gateway to College and Career (SDG2CC) program, and SDCE Foundation, up to 1,000 laptops will be distributed to students.
