

### Integrated Planning

This year, PRIE, in coordination with SLO coordinator & Program Review Co-chair, Marne Foster, supported the integrated planning process through:

- ◆ 99 individual data reports to support instructional program review
- ◆ 5 presentations/workshops to inform about integrated planning changes, labor market analysis, and administrative/program review with faculty, classified professionals, and administrators
- ◆ 8 campus labs Planning System trainings over two days, attracting a total of 71 enrollments/45 attendees (unduplicated).

# Did you know that...?

San Diego Continuing Education is one of California's noncredit vocational education top providers:

- We have more *Full Time Equivalent Students (FTES)* enrolled in *Career Technical Education (CTE)* programs than any other institution in California.
- SDCE accounts for three out of ten of California's FTES enrolled in CTE programs.
- An 88% increase in institutions offering CTE programs in California is expected within the next two years.

According to SDCE CTE students, the top factors that help students continue attending their classes are:

- Interesting classes (71% said this helped them to continue to attend their Fall 2017 classes).
- Receiving encouragement and feedback from instructors (64% mentioned it).
- Friendships (46% answered that having friendships with class members helped them to continue attending their classes).
