SDCCE's Enrollment Update Summary

Data as of 02/12/2024

Enrollment for spring 2024 started on December 4th, 2023. The early registration and enrollment efforts have proven to be positive. Spring classes started on January 31st, 2024, and will end on June 8th, 2024.

SDCCE's overall enrollment for spring stands at 25,692 (13% greater than this time last year, and an 2% increase from last week), with a fill rate of 67%, which is less than last Spring (76%). SDCCE's overall headcount is currently 14,101 an increase of 8% compared to this time last spring (13,089) and a 2% increase to last week (13,875). FTEF scheduled for the spring semester is 3% higher than last spring (188.90 to 183.77).

Enrollment management efforts continue, with 38% of scheduled sections starting 2/13/2024 or later (418 out of 1,094).

Fall update

SDCCE's overall enrollment for fall stands at 29,094 (11% greater than this time last year), with a fill rate of 65%, less than last fall (70%). SDCCE's overall headcount is currently 15,823, an increase of 14% compared to this time last fall (13,934). FTEF scheduled for the fall semester is 9% higher than last fall (188.86 to 172.92).

Note: As we are nearing the end of the fall semester, minor adjustments may be observed in the weekly numbers reported for headcount and enrollment due to the combination of continuous roster updates and fewer sections being opened. To account for this situation, week-to-week comparisons are not included in the executive summary for the fall semester.
