SDCCE's Enrollment Update Summary

Data as of 01/22/2024

Enrollment started for fall 2023 on July 24th. The early registration and enrollment efforts have proven to be positive. Fall classes started on September 5th, 2023, and will end on January 27th, 2024.

Enrollment continues to be strong for the fall semester. SDCCE's overall enrollment for fall stands at 29,568 (11% greater than this time last year), with a fill rate of 67%, less than last fall (73%). SDCCE's overall headcount is currently 15,940, an increase of 13% compared to this time last fall (14,087). FTEF scheduled for the fall semester is 9% higher than last fall (188.91 to 172.92).

Spring update

Spring classes will begin on January 31st, 2024. SDCCE's overall enrollment for spring stands at 21,745 (20% greater than this time last year, and a 9% increase from last week), with a fill rate of 59%, which is less than last spring (72%). SDCCE's overall headcount is currently 12,104 an increase of 14% compared to this time last spring (10,587) and an 8% increase to last week (11,194). FTEF scheduled for the spring semester is 5% higher than last spring (185.84 to 176.86).

Note: As we are nearing the end of the fall semester, minor adjustments may be observed in the weekly numbers reported for headcount and enrollment due to the combination of continuous roster updates and fewer sections being opened. To account for this situation, week-to-week comparisons are not included in the executive summary for the fall semester.
