

# SDCCE's Enrollment Update Summary

Data as of 6/17/2024

#### Summer Update

Enrollment for summer 2024 started on May 13<sup>th</sup>, 2024. The early registration and enrollment efforts have proven to be positive. Summer classes starts on June 10<sup>th</sup>, 2024, and will end on August 24<sup>th</sup>, 2024.

SDCCE's overall enrollment for summer stands at 14,525 (9% greater than this time last year, and a 5% increase from last week), with a fill rate of 89%, which is greater than last summer (74%). SDCCE's overall headcount is currently 10,053, an increase of 7% compared to this time last summer (9,390) and a 4% increase from last week (9,644). FTEF scheduled for the summer semester is 24% less than last summer (71.40 to 94.14).

Enrollment management efforts continue, with 30% of scheduled sections starting 6/18/2024 or later (130 out of 430), which is less than last summer (32%).

## **Spring Update**

SDCCE's overall enrollment for spring stands at 30,074 (4% greater than this time last year), with a fill rate of 63%, which is less than last spring (65%). SDCCE's overall headcount is currently 16,462, an increase of 7% compared to last spring (15,389). FTEF scheduled for the spring semester is 3% greater than last spring (191.51 to 186.09).

**Note:** As we are nearing the end of the spring semester, minor adjustments may be observed in the weekly numbers reported for headcount and enrollment due to the combination of continuous roster updates and fewer sections being opened. To account for this situation, week-to-week comparisons are not included in the executive summary for the spring semester.
