

SDCCE's Enrollment Update Summary

Data as of 8/19/2024

Fall Update

Enrollment for fall 2024 starts on July 8th, 2024. The early registration and enrollment efforts have proven to be positive. Fall classes started on August 28th, 2024, and will end on January 25th, 2025.

SDCCE's overall enrollment for fall stands at 21,683 (28% more than this time last year, and a 7.1% increase from last week), with a fill rate of 67%, which is greater than last fall (58%). SDCCE's overall headcount is currently 12,420, an increase of 19% compared to this time last fall (10,401) and a 7.2% increase from last week (11,586). FTEF scheduled for the fall semester is 2% more than last fall (180.90 to 177.52).

Summer Update

Enrollment for summer 2024 started on May 13th, 2024. The early registration and enrollment efforts have proven to be positive. Summer classes started on June 10th, 2024, and will end on August 24th, 2024.

SDCCE's overall enrollment for summer stands at 14,280 (4% less than this time last year, and a 1% decrease from last week), with a fill rate of 78%, which is greater than last summer (69%). SDCCE's overall headcount is currently 9,893, a decrease of 4% compared to this time last summer (10,289) and a 0.4% decrease from last week (9,930). FTEF scheduled for the summer semester is 26% less than last summer (72.13 to 97.07).

Note: As we are nearing the end of the summer semester, minor adjustments may be observed in the weekly numbers reported for headcount and enrollment due to the combination of continuous roster updates and fewer sections being opened. To account for this situation, week-to-week comparisons are not included in the executive summary for the summer semester.
