SDCCE's Enrollment Update Summary

Data as of 1/21/2025

Spring Update

Enrollment started for spring 2025 on December 3rd, 2024. The early registration and enrollment efforts proved to be positive. Spring classes will start on January 29th, 2025, and will end on June 7th, 2025.

SDCCE's overall enrollment for spring stands at 23,199 (7% more than this time last year, and a 10% increase from last week), with a fill rate of 70%, which is greater than last spring (59%). SDCCE's overall headcount is currently 12,607, an increase of 4% compared to this time last spring (12,104) and a 9% increase from last week (11,564). FTEF scheduled for the spring semester is 3% greater than last spring (185.84 to 190.92).

Fall Update

Enrollment for fall 2024 started on July 8th, 2024. The early registration and enrollment efforts have proven to be positive. Fall classes started on August 28th, 2024, and will end on January 25th, 2025.

SDCCE's overall enrollment for fall stands at 29,569 (0.003% less than this time last year, and a 0.09% increase from last week), with a fill rate of 71%, which is greater than last fall (67%). SDCCE's overall headcount is currently 15,800, a decrease of 1% compared to this time last fall (15,940) and a 0.1% increase from last week (15,790). FTEF scheduled for the fall semester is 1% less than last fall (188.91 to 186.78).

Note: As we are nearing the end of the fall semester, minor adjustments may be observed in the weekly numbers reported for headcount and enrollment due to the combination of continuous roster updates and fewer sections being opened. To account for this situation, week-to-week comparisons are not included in the executive summary for the fall semester.
