

# SDCCE's Enrollment Update Summary

Data as of 2/10/2025

### **Spring Update**

Enrollment started for spring 2025 on December 3<sup>rd</sup>, 2024. The early registration and enrollment efforts proved to be positive. Spring classes will start on January 29<sup>th</sup>, 2025, and will end on June 7<sup>th</sup>, 2025.

SDCCE's overall enrollment for spring stands at 27,114 (6% more than this time last year, and a 3% increase from last week), with a fill rate of 77%, which is greater than last spring (67%). SDCCE's overall headcount is currently 14,227 an increase of 1% compared to this time last spring (14,101) and a 2% increase from last week (13,990). FTEF scheduled for the spring semester is 3% greater than last spring (188.90 to 194.11).

Enrollment management efforts continue, with 34% of scheduled sections starting 2/11/2025 or later (346 out of 1,003).

### Fall Update

Enrollment for fall 2024 started on July 8<sup>th</sup>, 2024. The early registration and enrollment efforts have proven to be positive. Fall classes started on August 28<sup>th</sup>, 2024, and will end on January 25<sup>th</sup>, 2025.

SDCCE's overall enrollment for fall stands at 28,490 (2% less than this time last year), with a fill rate of 67%, which is greater than last fall (65%). SDCCE's overall headcount is currently 15,638, a decrease of 1% compared to this time last fall (15,823). FTEF scheduled for the fall semester is 1% less than last fall (188.86 to 186.78).

**Note:** As we are nearing the end of the fall semester, minor adjustments may be observed in the weekly numbers reported for headcount and enrollment due to the combination of continuous roster updates and fewer sections being opened. To account for this situation, week-to-week comparisons are not included in the executive summary for the fall semester.
