Called to Order

 - a. CVC POCR Resolution-2nd Reading | [Noncredit Inclusion in California Virtual Campus/ Online Education Initiative](#) | Greenberg

Discussion Summary

The body recommended that the two actions for the initiative be compressed into one and that a discussion with North Orange be initiated, as no prior discussions have taken place between either institutions.

The two original actions were:

1. Advocating for the inclusion of noncredit community college courses from San Diego College of Continuing Education (SDCCE) and North Orange Continuing Education (NOCE) in the California Virtual College Exchange (CVC.edu) to provide students statewide with access to these courses.
2. Advocating for the creation of a new webpage or website dedicated to noncredit community college course offerings, including SDCCE and NOCE, within the CVC-OEI system to further increase student access to noncredit courses statewide.

After further discussion, a motion was made:

Motion: *To compress the two actions into one and remove North Orange entirely from the proposal.*

Motion approved: The motion was moved by 1st Ingrid Greenberg and 2nd John Bromma. Passed

b. [Travel Request Protocol Update](#) | Surwilo

Discussion Summary-

A new guideline was developed and presented to the body regarding the updated travel fund policy. The revised policy aims to maximize professional development opportunities while ensuring equity and financial sustainability. Key updates include funding caps, eligibility limits, and a streamlined approval process to manage resources effectively, especially given the depletion of sabbatical-derived funds.

The body recommended reducing the funding cap from \$7,200 per conference up to \$1,800 per individual to allow more participants to benefit, rather than limiting funding to only seven individuals per semester. This adjustment aims to make the process more equitable for all. The senate body understands that the senate funds may not be sufficient to fund every faculty member's request to travel or participate in conferences.

Motion: A maximum of one approved event per faculty member per semester up to \$1,800. Reduce the funding cap from \$10,000 to \$7,200 per conference. Motion approved.

Weinroth emphasized the importance of faculty representatives from all disciplines participating.

Weinroth called for faculty members from all disciplines to join the committee.

Weinroth reported that he had brought the Senate's proposal to revise the manager screening process to ensure greater faculty involvement to DGC.

Discussion Summary

Several questions arose regarding the two newly created positions:

1. Evaluation: How will these faculty members be evaluated?
2. Program Inclusion: What program will these faculty members report to?
3. Funding Continuance: If positions are deemed necessary beyond one year what is the strategy for continuing these positions?
4. Necessity: What is the scope of need for a VA counselor at SDCCE?
5. Scope of Work: Will these counselors be available to assist outside their designated program, including supporting other counselors such as those in the Affinity Program?
6. Funding Restrictions: How are these positions at the 3 credit colleges funded and are there similar restrictions, given that CE is mirroring their model?

The body raised concern that their voice was not included in the determination of these positions as outlined in the Faculty Priority Hiring Committee (FPHC) processes.
