8. Inadequate IT Support for CE Programs –McGavock
 - McGavock reported that President Cortez stated IT staffing decisions are made by the district not the campus. McGavock noted some equipment and software is outdated or out of warranty and unable to handle normal tasks. Additionally, the lack of appropriate IT support is

both a safety and institutional issue which effects student instruction and negatively impacts student enrollment.
