Academic Senate Update

Academic Senate update by John Bromma, Academic Senate President

- Met on 9/21 for first Academic Senate Meeting of the Year
- Read the Motion on Hyflex that was passed by Academic Senate
- AS is working with Jessica Luedtke to craft additional language for the Strategic Plan
- The Academic Senate is continuing to amend and streamline language in their constitution, since it has not been done in over 15 years. They are working to on how to determine voting delegates and representation among programs

Classified Senate Update

Classified Senate update by Neill Kovrig, Classified Senate President

- Classified Senate met yesterday (9/21) as part of its regular meeting cycle and had a lengthy discussion, including Laurie Cozzolino, regarding the Classified Professional Development Subcommittee that was approved last year, They will be soliciting feedback and participants from the Senate and the general Classified Professional population to serve on the subcommittee and help to plan for STAR Conference in March 2022.
- The Classified Senate wants to be sure to include Classified Management in the planning process for professional development offerings, to be sure that they receive as much consideration as possible with regard to both the STAR conference and ongoing professional development offerings.
- CS spoke about the return to onsite activities, and discussed potentially conducting a survey to gather input on observations and recommendations that they could submit anonymously
- Discussed the Institutional Goals and Objectives, with no changes, and with hope that as the objectives and planning continue, we can address the frequent disconnect between programs and Classified Professionals
- Announced the possibility of a video series to spotlight Classified Professionals and reconnect folks in a community setting
- Esther Anthony-Thomas added that there is a need for a more collaborative approach and some confirming of procedures to solidify our roles and work in unison

Student Report update by Vinzent Balaoing, Student Representative

• Vinzent shared that students are getting ready for elections, and they have asked him to return as President. Students who are back on campus are engaged in their classes

Reopening

- Vice President Sabanos shared the case rate in San Diego is declining, and the Labor Day spike that people were anticipating has not surfaced

- VP Sabanos is meeting with the IT Director to discuss the need for additional IT support, and the needs brought forward by the Academic Senate's Hyflex motion.
- Worked with IT to troubleshoot connectivity issues and upgrade systems and wireless systems

Enrollment Management

Enrollment Management update by Michelle Fischthal, Vice President Instructional Services

- In terms of fall, the District's report shows that we are at 73% filled for the semester. We still have some short-term and late-term courses starting at various campuses, and we will continue to try to increase the number of classes based on demand.
- Deans and faculty leadership are engaged in conversations about spring. There are a number of considerations based on instructional and operational perspectives. We are finding a lower vaccination rate among ESL students, which will affect how many classes we can open for spring. Instructional Services is looking at different data points to help inform what the scheduling for spring should look like. The intent of the programming is student-centered, such that we are not only meeting the needs of our community, but looking at ways to engage with our community.
- There is a phased approach to developing the schedule. Phase two this semester was bringing back hard-to-convert classes, and phase three will be bringing back additional classes so that we are supporting our community.

ASB

Update by Shakerra Carter, Acting Vice President, Student Services

• First ASB advisors will be meeting tomorrow for the first time this semester. They are looking forward to working with students to facilitate elections, and bringing student leadership back to help promote our student vaccination incentive program, develop welcome week activities, and bring energy and awareness to our student body.

Access, Retention, and Completion Committee

Update by Shakerra Carter, Acting Vice President, Student Services

• VP Carter shared her report with VP Fischthal who added that the ARC committee will be meeting tomorrow and will be helping to develop the new enrollment management plan, which is part of the new strategic plan.

SDCE Foundation

Update by President Boger on behalf of Laurie Coskey, Executive Director SDCEF

- The Foundation is implementing several programs for which they are hiring new staff.
- SDCEF has two grants by the City of San Diego, but they have not completed the contracts. One of the programs is to help give out 650 computers and Wi-Fi hotspots to our students. The other is to add into our Gateway program a pathway for high school completion
- WIOA Program for immigrants, refugees, and English learners is almost fully staffed, and Victor Gonzalez is now the lead on that program.
- Apprenticeship Readiness Program is in its third cohort which began on September 7, and partnerships have been created with organizations including Clark Construction, the City of San Diego Pure Water Project, and the San Diego Airport project. The populations being served are those who have traditionally been left out of the building trades.
