 - Mission Level of agreement (87% agree); like or dislike; should be revised (50% said no; 20% Yes with minor edits; 15% yes; 16% not sure)
- Vision, Philosophy and Core values
 - Majority 86% agree with the values; Majority did not feel that it needed to be revised)
- Institutional SLO Review
 - o 78% strongly agree Social Responsibility Outcome
 - \circ 49% no to revision
- Proposed SLO Diversity, Equity, Inclusion, Anti-racism and Accessibility
 - \circ 42% want to add the SLO
 - 37% do not want to add the SLO
- Recommended timeline:
 - ISLO SLO Taskforce Review results, route to Academic Senate; review in March; back to academic senate in April for final review Bring to EGC in May
 - Guiding Principles PIE Committee to review and feedback; Draft 2 and back for approval to EGC in May
