#### AB86 Update

Academic Senate President Pawlak provided a brief update on AB86 activities:

- The San Diego Adult Education Regional Consortium Draft Plan-to-Date was submitted to the state on Friday, October 31. The document consisted of 350 pages and a culmination of rigorous efforts by the AB86 writers and workgroups. The document included five program areas and seven objectives for each program. The Deans have been kept in the loop and were provided their own word document copy to make changes and edits, which will be incorporated into the December document submission. The next phase in the project is to work with local workforce investment boards, and job placement centers. The Draft of the plan will be submitted on December 31.
- Interim President Kastelic announced Tom Schaaf will be joining AB86 as a consultant to assist with making contact with the workforce boards.

# **Continuing Education Holiday Reception**

Interim President Kastelic announced the Continuing Education Holiday Reception is scheduled for Tuesday, December 9, from 2:00 - 3:30 and encouraged all to attend.

#### **Board of Trustees Visit to Continuing Education**

Interim President Kastelic shared that the location for the Board of Trustees meeting at Continuing Education in April has yet to be decided. CE Mesa and ECC are being considered.

#### **Enrollment Management**

Vice President Ellison shared the following:

## SB1456 Update

Vice President Ellison reported that the state-wide workgroup involved with the noncredit funding is meeting on December 16. It is hoped that a final determination of the noncredit funding formula will be made and the SSSP Noncredit Plan can be rolled out in February.
