Ongoing Business Items

Institutional Effectiveness Cycle

The Institutional Effectiveness Cycle document was distributed and reviewed for revisions. After a brief discussion regarding the layout of information it was decided that the document could reflect more clarity. The document will be taken to each constituency for input and recommendations for change and brought back to EGC for further discussion. Vice President Brian Ellison will contact Lorrain Collins at the District to inquire when Continuing Education's goals are due.

WASC

Ellison reported in preparation of the 2016 WASC Accreditation Visit, member selection for the Steering Committee and Leadership Teams will occur this fall, to be completed by the end of October. Workgroups will be developed in spring and identified by Standards. Ellison will update EGC as actions occur.

AB86 Update

Pawlak provided a brief update on AB86 activities:

- The Regional Consortium Plan-to-Date was completed and submitted on July 31. The deadline for submitting the second Plan-to-Date is October 31. The workgroups have been reorganized to integrate the writers of the plan with the programs involved.
- An AB86 Adult Education Regional Planning Summit is scheduled for Monday, October 6, through Tuesday, October 7, at the Sheraton Grand Hotel in Sacramento. Timothy Pawlak, Brian Ellison, Rosa McCollum, and Jamil Person will be representing San Diego.
- Other key dates for the Regional Comprehensive Plan are: Due date for the first draft of the Plan is December 31, with the final due to the State on March 1.

SB1456 Update
