Building Successful Futures at San Diego's Community Colleges November 2024 – Education Facilities Bond









Our Mission

The San Diego Community College District (SDCCD) is dedicated to providing accessible, high-quality education and support services to a diverse student population. Our mission is to empower students to achieve their educational goals and contribute to our community's economic, cultural, and social vitality.

SDCCD significantly impacts the community and generates a return on investment for its students, taxpayers, and society. SDCCD's four colleges, City College, Mesa College, Miramar College, and the College of Continuing Education, prepare students to enter San Diego's workforce or to go on to higher education to train for careers requiring advanced degrees. **One out of every 46 jobs** in San Diego County is held by a former SDCCD student.

Our Challenges

As San Diego's leading institution for job training - including for first responders, nurses, emergency medical technicians, and, increasingly, for careers in biotechnology, cyber defense, and sustainability fields - SDCCD must continue to provide cutting-edge academic and career training facilities and technologies required to be responsive to continuously changing industry needs driven by global workforce industry changes and demographics.

Over the last decade, the education and training needed to fill jobs in our regional economy have continued to evolve due to new technologies and economic changes. Many jobs in demand today did not exist a decade ago, and new training programs are needed to meet this evolving workforce demand. In addition, the needs of community college students for affordable housing, transportation, childcare, and food have impacted students with challenging roadblocks in their ability to continue their education and job training programs.

San Diego's community colleges urgently need to upgrade and repair outdated facilities and offer new state-ofthe-art educational facilities to better prepare students for successful careers that will support their families and contribute to our region's economic growth.

Addressing The Needs of Our Students

Each of our colleges has developed a comprehensive facility plan identifying priority projects that could be funded by a new bond measure proposed for 2024. For SDCCD to successfully educate San Diego's future workforce, new local bond funding is needed to repair, update, repair, and replace aging and outdated educational facilities.

SDCCD has not had a bond measure on the ballot for more than 15 years, and during that time, all available bond funding has been used to replace aging facilities. But during the last two decades, district educational facilities not covered by previous bonds have continued to age and need repair and replacement. There is a growing need for new facilities to house advanced job training and educational programs.

Priority Projects for the SDCCD 2024 Bond Measure

The District will include a comprehensive list of needed facilities as part of the new bond measure that will be presented to the Board of Trustees and be placed before the voters on the November 2024 ballot.

The 2024 Bond Measure will focus on the much-needed educational facilities our college campuses need to successfully meet the demands of our future workforce. The 2024 Bond will help SDCCD continue to build successful futures for our students by:

- Upgrading job training facilities for high-wage jobs in construction, electrical, manufacturing, auto technology & computer technology,
- Upgrading classrooms and labs to train nurses and other health care workers,
- · Creating new childcare facilities for student families,
- Upgrading instructional technology for Science, Engineering, Arts & Math programs,
- Upgrading classrooms and labs for firefighter/paramedic & other 1st responder programs,
- Repairing outdated, deteriorating classrooms, labs, and college buildings,
- · Creating facilities for training for vets & active-duty military,
- Increasing the use of solar/renewable energy to reduce energy costs and benefit the environment.
- Creating new affordable student housing to help address San Diego's housing shortage.

The program works with 11 partner and referral agencies and 4 SDCCE partner and referring programs. Students may also self-refer.

Long-term and permanent housing remains the greatest challenge in relation to programming and supporting students facing varied levels of housing insecurity. Placement is dependent on continued resources and affordable housing options.

PATHWAYS is presenting at the State's Equity Conference in Anaheim, Ca-April 8-9, 2024

- PATHWAYS Team including the Dean will present at NCORE, June 1, 2024 as the first non-credit student support retention program accepted to be part of the conference.

V. <u>FINANCE REPORT</u>: Mary LeDuc/Woody Ledford

- Donations are up primarily because of Lucky Duck Foundation \$142K
- Budget slightly behind last year
- Grant contract revenue is a bit down- waiting for last ARP grant payment
- Program expenses down due to ARP starting later in the year
- New ARP contract was just renewed
- Expenditures ETi contracts revenue is up from last year
- ETi expenses are up due to the new contracts
- Program subcontractors- EMT Program and ETi based training are up compared to last year
 - o EMT training through the Foundation- fee based program
 - o Training held at Miramar Campus
- Administrative expenses are up due to the Interim CEO
- Personnel costs are up- but have only spent 11% of the budget (17% of the year-actual)
- Overall expenses are up 13% from last year, but we are at 11% for the year (actual should be 17%)
- Scholarships Awards- goal same as last year or a bit more
