# **Academic Senate Update**

Academic Senate update by Rachel Rose and Matthew Rivaldi, Academic Senate

- During the December meeting, two resolutions were passed supporting letters sent to BOT regarding DACA resources and refunding the police.
- Four motions were also passed regarding a peer online course review (POCR), an institution-wide survey to report to the DO, internet access, and Senate participation in future relief-funding discussions.
- Academic Senate will hold elections for President, Vice President, and Treasurer Positions in Spring 2021.

Discussion ensued in response to the motions presented.

Academic Senate to support developing a POCR proposal to fund faculty training and evaluating a pilot number of courses, with expectation of ongoing funding to support POCR requirements.

- o SDCE-wide survey to gain situational awareness of current email and communication use (or lack thereof), effectiveness, required features, and blocking issues. Present findings and required resources to district.
- o Administration revisit the September 15, 2020 resolution and report back on a solution to provide adequate internet access to the next Academic Senate meeting.
- o SDCE-wide survey to gain situational awareness of long-term quality internet access for instruction both on campus and for online courses. Present findings and required resources to district.

- Spring Registration is in progress, and is currently at 39% capacity for courses that will begin in February.
- Summer scheduling is also in progress, with primarily online courses.

# ASB/ARCC

- Students are continuing to provide their reports at District meetings.
- Scholarship applications are out, so all students are encouraged to apply and attend a virtual event on April 20<sup>th</sup>.
- CE's ASB did a winter celebration and is working with Dean Melissa Hough to have a mental health event for students.

#### **Budget Committee**

• The next committee meeting will be held in the following month.

Discussed highlights from the Governor's Budget Report, including a one-time Block Grant reimbursement, a cost of living amount to the District of 2.0 million, and 1.5% increase for living adjustments with adult education statewide. There is a big emphasis on student support.

- There was a Microsoft Teams training held earlier today, January 13.

#### **SDCE Foundation**

Update by Laurie Coskey, Executive Director SDCEF

- In December, 22.4 million, 400k and 200k in Grant Requests were submitted.
- Four grant requests were sent to WIOA for specialized funding through the SD Workforce Partnership, two of which were applied for African American students, homeless and immigrant students.
- Foundation employees hired have been informed that they are hired on soft funds, and it is not a position directly with SDCE, so we are continuing to hire and implement these changes on such soft funds.
- We are collaborating with the upcoming Town Halls celebrating the Black History Month on February 17 and February 24.

# **Annual integrated Planning**

- Feedback from the cross-departmental group that reviews Resource Requests prior to the break has been completed and sent back to requesters this week for changes via Campus Labs.
