- There are six new institutional goal categories: Student Enrollment and Programming, Student Experience and Pathways, Diversity, Equity, and Inclusion, Organizational Effectiveness, Partnerships, and Stewardship of Resources.
- PRIE is reviewing and finalizing the plans and will then prioritize the activities for the Institutional Strategic Plan and will then finish drafting the Institutional Strategic Master Plan and its components: Student and Community Profile as well as mission statements and program summaries from all the different plans
- Any revisions will be brought to EGC for final review and acceptance in May
- PIE will work with Brailsford and Dunlavey (B&D) which will support the facilitation and prioritization of activities within the unit plans throughout the month of February
- B&D feedback session for prioritization of strategic plan activities at PIE meeting in March
- Committee members inquired about obtaining student input in a feedback session
- B&D is funded by the District there is no potential for additional funding for this project
