Reports and Recommendations

President's Report

Achieving the Dream

President Beebe provided a follow-up to his action item to provide additional information on *Achieving the Dream*, and distributed a copy of an email he received from Carol Lincoln, Senior Vice President of the organization. Ms. Lincoln's response reflected that the cohort for 2013 had already been selected; however, the process of accepting applications for 2014 would begin in a few months. The question was raised if it would be advantageous to join the *Achieving the Dream* organization with the District, SDICCCA, or as a stand-alone institution. After a brief discussion, it was determined that when we join the *Achieving the Dream* organization, we would join as a District.

Academic Senate Report

Timothy Pawlak reported on the following:

- Senate Bill 173 A handout of the current SB 173, introduced by Senator Liu, with amendments highlighted was distributed. This bill will impact the whole noncredit program. SB 173 was also distributed and discussed at the District Budget meeting. Vice Chancellor Lynn Neault provided some good feedback at that meeting in regard to fees and bringing a fee structure to noncredit classes. The colleges have a system in place; however the question of how such a structure could be managed for noncredit was discussed as the institutions are very different. The Academic Senate is opposed to this bill and Council Members were urged to keep this Senate Bill in the forefront of conversations and how it would impact Continuing Education.
- Senate Bill 173 Comments/Feedback from CE Academic Senate Chairs & Leadership A handout with an overview of SB 173 with the Academic Senate leadership's position was also distributed.
- The question of where course completion certificates from ESL and other programs are reported at the District and State was raised. Vice President Brian Ellison responded this information is reported through his office, Instructional Services, then to the District and State via the MIS reporting system. A caveat to this is even though the District has all Continuing Education's information, not all is reported to the State.

Classified Senate Report

Neill Kovrig reported on the following:

- The resolution to support noncredit programs was passed and was shared with DGC, the College Classified Senates, as well as the State Classified Senate
- Classified Senate scholarship recipients were selected: one per each campus for \$150 each to be presented at the scholarship event on Wednesday, May 22
- The Classified Senate will be meeting with Vice President Bob Parker to discuss options and workshop ideas for the Classified Staff Professional Development Day held on July 11
- The Classified Leadership Institute will be held in Sacramento June 13-15. Funds have been authorized out of the Classified Senate travel budget to send Continuing Education's Outstanding Classified Employee of the Year to this conference where they will be recognized along with other state-wide outstanding classified employees.

Finance, Grants, & Operations

Interim/Temporary/Out of Class Assignments and Hiring Process (4200.9)

Neill Kovrig requested clarification of the interim/temporary/out of class assignments and hiring process as it relates to classified staff. He reported there had been some discussion at the last Classified Senate meeting and questions were raised on the procedures of recruitment of "acting" positions. President Beebe and Vice President Bob Parker responded that the institution has been operating on "past practices" of administration selecting individuals to fill temporary positions so as to expedite filling a need. After reviewing policy 4200.9, it was found that the policy has not been closely followed as stipulated. In the future, the policy will be followed.

The Classified Senate will provide Vice President Parker with a "priority" hiring list for key positions, (similar to what the Academic Senate is providing to the President), to be considered when the hiring freeze

Round Table:

President Beebe shared that he has personally written a letter in support of Assembly Bill 806, introduced by Assemblyperson Wilk. This bill has to do with the 50% rule to include counselors, librarians and other non-instructional areas. The bill would provide community colleges with increased flexibility in expending their general fund revenue and better meet the needs of their students. The letter was faxed to relevant legislators.

Vice President Bob Parker reported interviews are taking place for the Office Manager position at North City. Tomorrow the application process closes for the open Accounting Technician position, and the BIT Instructional Aid position has been reactivated for internal and external recruitment.

Timothy Pawlak announced he would be attending the Faculty Leadership Institute June 13-15, in Sacramento.

Marie Doerner shared that she has requested past information from faculty on a previous priority hiring listing to assist with the Academic Senate's Action Item to provide recommendations to the President for faculty priority hiring considerations. Also, the Program Chairs requested a due date to provide this information. President Beebe replied he would like this information available to him by the end of the semester, June 8. Vice President Ellison shared that the Deans are also looking at data for recommendations.
