## **President's Report**

President Beebe reported that he, Vice President Ellison and Counselor Stephen Flores attended the Student Success and Support Program Implementation Summit in Sacramento on Monday, September 23, and Tuesday, September 24. The summit was held to support college planning and implementation efforts for the Student Success and Support Program (SSSP). Each college was invited to send a team of three representatives to hear presentations and participate in discussions about SSSP topics that included: program and budget requirements, new funding guidelines, MIS data elements, as well as the latest assessment, orientation, counseling, advising, and student education planning strategies.

#### **Instruction & Student Services**

- Add December 17, 2014, as an instructional day in Fall
- Begin Summer Session on Monday, June 8, 2015.

## **Faculty Position Hiring Process**

President Beebe reported that he and Vice President Ellison have discussed the faculty hiring process, and it was determined that any information the Office of Instruction and Student Services has will be made available to the Academic Senate. President Beebe is asking in return that the Academic Senate share any information regarding this process with the Office of Instruction and Student Services. This will ensure synchronization and transparency with the system. President Beebe apologized if this did not occur with the recent faculty priority hiring recommendation process.

The possibility of "dual" disciplinary hiring for faculty was discussed. The idea was raised of looking at the hiring of faculty members with qualifications to teach in two or more disciplines in programs that are at risk. However, this could be expanded to include all programs in the future. If this idea is worth pursuing, a dialog with Human Resources will need to be started.

ACTION ITEM: This item will be taken back to the October 15 Academic Senate meeting for discussion to see if the Senate would like to pursue the idea of a "dual" disciplinary hiring option to address the at-risk programs, and report back to EGC.

ACTION ITEM: Vice President Parker will speak with Hunan Resources and find out if this is a viable idea and report his findings to President Beebe and Academic Senate President Pawlak.

### **Regional Adult Consortium**

President Beebe gave a report on the Regional Adult Consortium Program that came out of the Governor's Budget, May Revision. The program is a consortia of community college districts and K-12 Adult districts for the purpose of developing regional plans to better serve the educational needs of adults. \$25 million "upfront" money will be spread throughout the state to develop and implement these consortia, with subsequent ongoing funds. President Beebe distributed a handout that reflected the eligibility and criteria of the program. It was noted that Continuing Education is providing four

out of the five services reflected in section (b). The RFP for the consortia is targeted to be released in late December, with an award date in March and program implementation in July. It was noted that it would be advantageous to merge the concepts of the Regional Adult Consortium Program and SB 1456 to create a model for implementation that would provide a seamless mapping for students to be successful in their endeavors.

ACTION ITEM: Rudy Kastelic, consultant for Continuing Education, is working with President Beebe on the Regional Adult Consortium for Continuing Education. He will be invited to attend a future EGC meeting and provide information.

Timothy Pawlak suggested it would be beneficial with SB 1456 for Continuing Education to capture data reflecting student success and present findings in a simplistic organized fashion early on. This could then dovetail with the Regional Adult Continuum RFP submission.

A question regarding duplicate records was raised. After a brief discussion it was determined that moving forward the focus will be on the accuracy of new students coming into the system. This will ensure accurate information is being captured for the students being served.

President Beebe requested a SARS demonstration at a future meeting. Neill Kovrig agreed to provide the demonstration.

ACTION ITEM: Neill Kovrig will provide a SARS demonstration at a future EGC meeting.
