Reports and Recommendations

President's Report:

- President Beebe announced Sy Lyon, Dean of Basic Skills, Hospitality and Consumer Sciences will be retiring effective May 7, 2010. Due to the budgetary situation there will be no new hire for that position. The plan is to distribute the duties of Dean Lyon to current Deans. Dean Marcia Biller will acquire CalWORKS from Dean Lorie Howell. Dean Howell will move to the West City campus and assume Basic Skills and resident dean duties; and Brian Ellison's office will administer professional development.
- President Beebe reported Chancellor Carroll and Vice Chancellor Davis convened a
 Governance and Planning meeting on Tuesday, April 13, 2010, for Continuing Education
 faculty, staff, and administrators. The meeting was held at ECC from 2:00 3:00 pm.
 Topics covered in the meeting included enrollment, the San Diego State University access
 issue, community college baccalaureate degree proposal, budget issues, and the parcel
 tax legislation. (See attached). The meeting was well attended with good representation
 from faculty, staff, and administrators.
- President Beebe reported the process for Continuing Education Student Attendance Cards is now underway and will shortly be implemented. Samples of what the cards will look like were distributed. The long term plan is that these cards will be able to be swiped and utilized electronically with dedicated computers for attendance in the future. It was reiterated that this is not an ASB card and it will not take the place of an ASB card.

Smoking Policy Revisited

President Beebe distributed a copy of the April 1, 2008 EGC Action Notes that reflect Continuing Education's consensus to follow the District's policy: "Smoking is prohibited inside any building or in any outdoor area within 25' of a main exit, entrance, or operable window of any building owned and occupied or leased and occupied by the District." President Beebe reported that at the last Board of Trustee meeting people complained about cigarette butts and smoking on campuses. The Board of Trustees and Chancellor have requested the colleges and Continuing Education inform them of their current smoking policies and consider movement toward a "smoke-free" institution. There is a concern that Continuing Education leases many off site facilities and it may be difficult to police/enforce a "smoke-free" environment. Academic, Administrative, and Classified Senates will obtain copies of the colleges' smoking policies and compare them to the current CE policy. The constituencies will discuss and bring forth a recommendation to the next meeting.

Emergency Procedures Pamphlet

Vice President Parker reported in light of the recent seismic activity, Council Members were reminded that the District has an official reaction for what to do when an earthquake occurs. A "What to Do in an Emergency" pamphlet is posted in every classroom and every office space at every campus. These pamphlets provide important information in case of an emergency, such as earthquakes, fire, first aid, etc. Additional pamphlets will be sent to each office manager
