Reports and Recommendations

President's Report:

- President Beebe announced Chancellor's Cabinet was made aware that students are bringing animals (dogs) onto the College and Continuing Education campuses, and into the classroom stating they were "service animals." Many of these dogs are not service animals and are causing disruptions. President Beebe distributed the District's Administrative Procedure that defines use of service animals and implements Policy 3105 with regard to service animals on campus. San Diego Community College district will permit qualified students with disabilities to use service animals in District facilities and campuses in compliance with state and federal law. It was noted that "comfort" animals do not qualify under this procedure. A request was made to have this procedure linked to the website.
- President Beebe announced that EGC would not meet during the summer, with a caveat that an emergency meeting could be called as needed. The first meeting scheduled in the Fall semester will be scheduled for September. A schedule of meetings will be sent to Council Members.
- President Beebe distributed a copy of the current Continuing Education Mission, Core Values, Statements, and draft language for the Vision Statement (one document). Feedback from the Academic Senate indicated the Mission and Core Values Statements were reflective of the institution, but the Vision Statement, though brief, needed to indicate more specifically what Continuing Education is striving to be. The draft Vision says: *"San Diego Continuing Education strives to be the Nation's leading career development, college preparation and life-long learning provider."* This language more accurately captures what Continuing Education is doing in terms of our mission.

Esther Matthew will send the new language electronically to the Academic Senate for any feedback before the semester ends. Once President Beebe receives the feedback from Ms. Matthew, he will forward the revised Mission, Core Values, and Vision Statements to the Chancellor and Board of Trustees.

Administrative Governance Council Report:

Vice President Brian Ellison reported one recommendation was being brought to EGC from the Administrative Governance Council for consideration:

Continuing Education Attendance Statement

There has been a discrepancy in attendance practiced guidelines between statements in the Continuing Education Catalog and Registration Forms. The new statement will clarify and reconcile any discrepancies. The Administrative Governance Council (AGC) met, reviewed, and approved the Continuing Education Attendance Statement for recommendation to EGC. The document has been vetted through the Academic and Classified Senates.

Smoking Policy Revisited

Vice President Parker shared a suggestion was put forth from West City Campus to designate one spot on campus as the smoking area. Unfortunately the place chosen would violate the adopted policy: "*Smoking is prohibited inside any building or in any outdoor area within 25' of a main exit, entrance, or operable window of any building owned and occupied or leased and occupied by the District.*" Instead, the smoking stands that are too close to the operable doors will be moved so as to be in compliance with the policy. Signs will also be updated and posted. We have no control of offsite locations we don't own or regulate. If, however, violations of the smoking policy are observed at our campuses they should be reported to the Office Manager.
