Purpose

The San Diego Adult Educational Regional Consortium (SDAERC) asked the Office of Planning, Research, and Institutional Effectiveness (PRIE) to conduct a study that would allow the SDAERC to gauge its program's effectiveness and accountability. Feedback will help improve the SDAERC and assist towards the development of the new SDAERC strategic plan that will be submitted to the state by August 2024.

Methodology

The survey instrument provided a series of structured and unstructured questions designed to gain both quantitative (structured, numeric) and qualitative (open-ended comments) feedback. The survey addressed the following items:


- 1) Governance & administrative oversight
- 2) Program effectiveness including barriers and opportunities
- 3) Member agency effectiveness

PRIE conducted online survey data collection in April and May (4/24/2024 – 5/10/2024). Nine-hundred-fortyseven survey invitees who had been identified as contributors to the SDAERC were emailed one survey invitation followed by two reminders. A total of 55 respondents with 27 complete responses and 28 partial responses (49% response rate).

This report provides survey response tables and charts, as well as verbatim respondent comments.








CAEP Funding if used effectively to help us achieve SDAERC objectives.



I'm a new hire to SDCCE and I just now am learning what SDAERC is.


***** is instrumental in ensuring that the CAEP consortium operates effectively and in compliance with state regulations.
