Purpose

The San Diego Adult Educational Regional Consortium (SDAERC) asked the Office of Planning, Research, and Institutional Effectiveness (PRIE) to conduct a study that would allow the SDAERC to gauge its program's effectiveness and accountability. Feedback will help improve the SDAERC and assist towards the monitoring and continued implementation of the SDAERC strategic plan.

Methodology

The survey instrument provided a series of structured and unstructured questions designed to gain both quantitative (structured, numeric) and qualitative (open-ended comments) feedback. The survey addressed the following items:

- 1) Governance & administrative oversight
- 2) Program effectiveness including barriers and opportunities
- 3) Member agency effectiveness


PRIE conducted online survey data collection in June and July, 2023. Seven-hundred-ninety-three survey invitees who had been identified as contributors to the SDAERC were emailed one survey invitation followed by three reminders. A total of 38 surveys were completed (5% response rate).





















I hear about CAEP, but people are still hesitant to use this funding because we need an Expert that would help certain ideas be aligned what is allowable. I hear more of a No when there is an idea and it's not executed. However it does not mean it cannot be done. It's just that we need an Expert that is open on how to use this funding effectively to make sure we meet guidelines and student needs, to at least help that idea make it possible. An expert that is willing to collaborate and work with decision makers.

Our school needs to offer a Study Skills Class for all Ss. Offer it as a pre-req. for college classes and one imparticular for ESL Ss who come to our programs with very little education or study knowledge. Ask Ss how we can serve them better? What areas? How often? Maybe a Tutoring Dept at SDCCE programs?
